What is Planned Giving?

Planned giving is a way for **anyone** to support non-profits and charities through gifts made some time in the near future or through estate planning.

There are many ways to make a planned gift, but the most common method is through a bequest in a will or living trust.

Some planned gifts may provide a life-long income to the donor, through a “charitable trust,” while others provide more simple gifts of funds or real property through the will or trust.

Planned gifts may take many forms, including:

- Stocks or Bonds
- Real Estate
- Retirement assets
- Cash
- Insurance

Planned gifts may allow a donor to make a gift that is larger or more influential than they can make in their lifetime.

Planned gifts mean that the donor’s legacy and generosity continue to have positive impacts after the donor passes away, allowing their legacy to reach future generations.

There are also tax benefits* to the donor, including significant income tax deductions, reduced estate taxes, and/or reduced capital gains taxes.


**These tax benefits will depend on the structure of the gift and the donor’s personal financial situation, and should be carefully examined and managed by a qualified tax professional.*

By including River Fields in your estate planning, your generosity will help ensure the important land of our region, which we all treasure, survives for future residents to enjoy, appreciate, and learn from.



Your Planned Gift Can Impact the Land in Specific and Diverse Ways

 - ◊ Maintenance, management, and enhancement of publically-accessible Garvin Brown Preserve on the Ohio River
